NCIC released TOU 21-5 on October 22, 2021 for the following changes:

- Modification to the Originating Agency Identifier (ORI) File.
- Expanding REG and CGD max field lengths from 8 characters to 10 characters.
  - Helpfile changes.

#### What does this mean for CPI customers?

If your organization would like to implement the REG/CGD field length changes, CPI can update the forms, keys and help files to support it. This can be done for **2 billable hours**. If your organization includes Boat Data in the state **Hotfiles**, it may require an **additional 6 hours (at maximum)**.
